INCIDENT:

ON THE ABOVE DATE AND TIME I RESPONDED TO 1270 SOUTH BROADWAY AVENUE, BARTOW SENIOR HIGH SCHOOL IN REFERENCE TO A DESTRUCTIVE DEVICE/WEAPONS INCIDENT.

UPON ARRIVAL I MADE CONTACT WITH ASSISTANT PRINCIPAL DAN DURHAM (COMPLAINTANT). MR. DURHAM ADVISED WHILE HE WAS ON THE EAST SIDE OF THE CAMPUS NEAR THE GAZEBO/LAKE AREA, HE HEARD AN EXPLOSION AND LOOKED TOWARD THE GAZEBO AREA. MR. DURHAM ADVISED HE OBSERVED KIERA WILMOT (ARRESTEE) NEAR THE AREA AND APPROACHED HER. MR. DURHAM ADVISED KIERA TOLD HIM SHE WAS CONDUCTING A SCIENCE FAIR EXPERIMENT. MR. DURHAM ADVISED HE THEN LOCATED A PLASTIC BOTTLE THAT WAS USED TO CREATE THE EXPLOSION. MR. DURHAM ADVISED HE THEN CHECKED WITH WILMOT'S SCIENCE TEACHER WHO ADVISED IN NO WAY WAS WILMOT'S ACTIONS PART OF ANY CLASS WORK.

I THEN SPOKE TO WILMOT POST MIRANDA AND AFTER CONTACTING HER MOTHER AND FATHER ABOUT HER BEING IN CUSTODY.

WILMOT ADVISED SHE WAS TOLD BY A FRIEND HOW TO MAKE THE DEVICE. WILMOT ADVISED SHE BROUGHT FROM HOME A WATER BOTTLE, "THE WORKS" TOILET BOWL CLEANER, AND PIECES OF ALUMINUM FOIL. WILMOT ADVISED SHE DID NOT KNOW WHAT WOULD HAPPEN WHEN SHE MIXED THE INGREDIENTS. WILMOT ADVISED SHE THOUGHT IT WOULD JUST CAUSE SOME SMOKE. WILMOT ADVISED HER FRIEND ASSISTED HER IN FILLING THE BOTTLE AND WAS PRESENT WHEN IT EXPLODED, HOWEVER HE WALKED AWAY BEFORE MR. DURHAM APPROACHED HER. WILMOT ADVISED IT TOOK APPROXIMATELY THIRTY (30) SECONDS BEFORE THE BOTTLE EXPLODED. WILMOT ADVISED IN NO WAY WAS SHE TRYING TO HURT ANYONE OR CREATE A DISRUPTION OF SCHOOL. AT THIS TIME EFFORTS ARE BEING MADE TO IDENTIFY WILMOT'S FRIEND.

I THEN CONTACTED ASSISTANT STATE ATTORNEY TAMMY GLOTFELTY VIA TELEPHONE. I ADVISED A.S.A. GLOTFELTY OF THE CIRCUMSTANCES OF THE CASE AND SHE ADVISED THIS OFFICER TO FILE THE CHARGES OF, POSSESSING OR DISCHARGING WEAPONS OR FIREARMS AT A SCHOOL SPONSORED EVENT OR ON SCHOOL PROPERTY F.S.S. 790.115 (1) AND MAKING, POSSESSING, THROWING, PROJECTING, PLACING, OR DISCHARGING ANY DESTRUCTIVE DEVICE F.S.S. 790.161 (A).

WILMOT WAS CHARGED WITH THE ABOVE CHARGES VIA AFFIDAVIT AND TAKEN TO THE JUVENILE ASSESSMENT CENTER WHERE SHE WAS TURNED OVER TO STAFF. I COMPLETED A COST AFFIDAVIT AND PROPERTY RECEIPT FOR THE PLASTIC BOTTLE. THE BOTTLE WAS IMPOUNDED AS EVIDENCE.
